### \*\*\*IMPORTANT NOTICE\*\*\*

Instances involving jobsite damage, vandalism and/or graffiti of our portable restrooms have been on the rise over the past few years. Even if every effort is made to ensure the safety of the units, accidents happen. Vandalism is a major contributor to repair and loss costs. At this time, the replacement cost of a standard portable restroom is \$700, all other equipment replacement costs are listed below, equipment damaged beyond minor repair is the responsibility of the customer. While your insurance may cover rental equipment, the deductible may well exceed the cost of the unit.

Atlantic Heating & Cooling Service, Inc. (Atlantic Potties) includes a Damage Waiver Program with our Construction units and related equipment rentals as standard practice. Customers may opt-out of at any time by requesting a separate Opt-Out form. This form can be obtained by calling our office at 757-460-6100.
